The enclosed February 1st water & sewer statement is covering the last quarter of the year 2008. It is due by February 20th without penalty. All arrears and payments after Feb. 20th must be made by April 15th 2009, after which time we forward unpaid water & sewer to Ontario County to be levied upon property taxes. A reminder letter will be sent.

This bill also reflects the following rate increase:
Water: the minimum remains the same - \$24.00 for the first 6,000 gallons of water used; the overage is changing from \$3.50 for each 1,000 gallons of water over 6,000 gallons to \$4.50/1000 gallons. There is no change in meter rent.
Sewer: the minimum charge based on water consumption up to 15,000 gallons is changing from \$55.00 to \$65.00 per unit. The overage cost will remain the same at \$6.50 per 1500 gallons.



With all the snow we have had this winter, please remember that cars must be kept off the streets from 2:00am to 6:00am (from November 1st to April 1st) to allow efficiency in snowplowing. You may be ticketed and have the car towed away.

When removing snow from driveways & sidewalks, please check if the sidewalk has any excess snow. When this snow freezes it makes it difficult for pedestrians to get around it. Also, it is prohibited to plow or shovel snow from your property in the public streets.



Please note that, by law, the Village is not responsible for replacing broken or damaged mailboxes. Unfortunately, broken mailboxes do happen. It is usually the weight of ice and snow that breaks them.
