Mayor Johnsen called the meeting to order at 6:00 pm.

The minutes of the Regular meeting held on October 03, 2016 were read and approved upon motion from Trustee Buttaccio and seconded by Mayor Johnsen. The minutes of a Special Meeting held on October 6, 2016 were read and approved upon motion from Trustee Buttaccio and seconded by Mayor Johnsen. The October Treasurer's report was approved upon a motion from Trustee Buttaccio, seconded by Mayor Johnsen, voted on and unanimously carried, subject to audit. WHEREAS, the Village of Manchester Board of Trustees (hereinafter referred to as Village Board) has on Monday November 07, 2016 reviewed Part 1 of the Short Environmental Assessment Form for the Proposed Demolition of the Merrick Avenue Water Tower, and

WHEREAS, upon such review the Village Board has declared itself to be Lead Agency for under the provisions of the State Environmental Quality Review (SEQR) Regulations; and

WHEREAS, the Village Board has determined that it is the most appropriate agency to insure the coordination of the Action and for making the determination of significance thereon under the SEQRA regulations;

NOW, THEREFORE BE IT RESOLVED, that the Village Board does hereby designate itself as the lead agency for the Action identified above herein.

BE IT FURTHER RESOLVED, that the Village Clerk keep a copy of this Resolution on file at the Clerk's Office for public examination.

Negative Declaration - Unlisted Action for the Village of Manchester Proposed Demolition of Merrick Avenue Water Tower

After completing Part II of the Short Environmental Assessment Form, Trustee Buttaccio introduced the following NEGATIVE DECLARATION resolution, seconded by Mayor Johnsen who moved its adoption:

WHEREAS: In accordance with Section 8-0113 Article 8 of the New York Environmental Conservation Law, the Village Board of Trustees of the Village of Manchester has conducted an initial review to determine whether the proposed demolition of the Merrick Avenue Water Tower project may have a significant affect on the environment, and;

WHEREAS: The Village Board has completed Part I and Part II with the criteria set forth in NYCRR Part 617.6 and Part 617.12 of the Regulations, and;

NOW, THEREFORE, BE IT RESOLVED, The Village Board of the Village of Manchester, as lead agency, has determined on the basis of that review that (1) The proposed project constitutes an "Unlisted Action" since it has not been classified as a Type 1 Action or a Type II, and (2) that the proposed action described will not have a significant environmental impact and an Environmental Impact Statement will not be prepared.

The resolution was thereupon declared duly adopted.

Trustee Michael J. Buttaccio presented the following resolution and duly moved that it be adopted and was seconded by Mayor Nancy W. Johnsen:

RESOLUTION No.17-2016 BOND RESOLUTION DATED NOVEMBER 07, 2016 OF THE VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF MANCHESTER, NEW YORK, AUTHORIZING GENERAL OBLIGATION SERIAL BONDS TO FINANCE CAPITAL IMPROVEMENTS, AUTHORIZING THE ISSUANCE OF BOND ANTICIPATION NOTES IN CONTEMPLATION THEREOF, THE EXPENDITURE OF SUMS FOR SUCH PURPOSE, AND DETERMINING OTHER MATTERS IN CONNECTION THEREWITH.

WHEREAS, the purpose hereinafter described consists of demolition of a water tank on Merrick Avenue no longer of any use or value as authorized by the New York State Department of Health and to be undertaken by the Village Board of Trustees pursuant to the Village Law; and

WHEREAS, the Village owns another water tank located on Lehigh Avenue that is fully operational and approved by the New York State Department of Health; and

WHEREAS, the cost to make repairs to the Merrick Avenue tank is not a viable option at this time, and

WHEREAS, the Village, acting as lead agency under the State Environmental Quality Review Act and the applicable regulations promulgated thereunder ("SEQRA"), has completed its environmental review and, on November 07, 2016, has duly issued a negative declaration with

respect to the unlisted action and has determined that the implementation of the action as proposed will not result in any significant adverse environmental impacts; now therefore, be it

RESOLVED by the Board of Trustees of the Village of Manchester, New York (hereinafter referred to as the "Village"), by the favorable vote of not less than two-thirds of all of the members of such Board, as follows:

- Section 1. The Village of Manchester shall undertake the demolition of the Merrick Avenue Standpipe Water Tower, consisting of demolition, removal and grading and other incidental improvements that may be required in connection therewith for such demolition (hereinafter referred to as "purpose"), and general obligation serial bonds in an aggregate principal amount not to exceed \$45,000 and bond anticipation notes in anticipation thereof (and renewals thereof) of the Village are hereby authorized to be issued to finance said purpose.
- Section 2. The estimated aggregate maximum cost of said purpose, including preliminary costs and costs incidental thereto and costs of the financing thereof, is estimated to be \$45,000 and said amount is hereby appropriated therefor. The plan for financing of said purpose is to provide (i) \$45,000 by the Village borrowing from the Buildings & Additions Reserve Fund as an investment as permitted by Section 11 of General Municipal Law, entitled Temporary Investments, pursuant to section 6 c-n to be invested in the village debt obligations at 1.75% as herein authorized, so no outside bonding is necessary.
- Section 3. It is hereby determined and declared that (a) said purpose is one of the class of objects or purposes described in Subdivision 12 of Paragraph (a) of Section 12-a of the Local Finance Law, and that the period of probable usefulness of said purpose is hereby restricted to five (5) years, (b) the proposed maximum maturity of said borrowing is authorized by this resolution and will not be in excess of five years to be measured from the date of the borrowing, (c) the borrowed funds has a mandatory optional redemption date within two years of the date of issue to provide the reserve fund monies if funds are needed for which the reserve fund was originally established and there are presently no capital projects or improvements scheduled to use Building and Additions reserve moneys nor will this borrowing totally deplete said fund, (d) there is no intent to reconstruct or replaced said water tank, (e) said notes are not issued in anticipation of bonds for an assessable improvement, and (f) prior to the issue of the bonds or notes herein authorized, there will be provided the appropriate amount of current funds required by Section 107.00 of the Local Finance Law, if any.
- <u>Section 4</u>. The bonds and notes authorized by this resolution shall contain the recital of validity prescribed in Section 52.00 of the Local Finance Law and such bonds and notes shall be general obligations of the Village and all income received from water rents services and any other revenue to the water fund, and interest thereon, without limitation as to rate or amount, subject to statutory limitations, if any.
- Section 5. It is hereby determined that the Village reasonably expects to reimburse the Buildings and Additions Reserve Fund, from the proceeds of the obligations authorized hereby for expenditures, if any, from such fund that may be made for the purpose prior to the date of the issuance of such obligations. This is a declaration of official intent under Treasury Regulation §1.150-2.
- Section 6. The power to further authorize the issuance of said bonds and bond anticipation notes and to prescribe the terms, form and contents of said bonds and bond anticipation notes, subject to the provisions of this resolution and the Local Finance Law of New York, including, without limitation, the consolidation with other issues, the determination to issue bonds with substantially level or declining annual debt service, all contracts for and determinations with respect to, credit and liquidity enhancements, if any, and to sell and deliver said bonds and bond anticipation notes subject to the provisions of this resolution and the provisions of the Local Finance Law, is hereby delegated to the Village Clerk/Treasurer, the Village's chief financial officer. The Village Clerk/Treasurer and the Deputy Village Clerk/Treasurer are hereby authorized to sign by manual or facsimile signature any bonds and bond anticipation notes issued pursuant to this resolution, and are hereby authorized to affix to such bonds and bond anticipation notes the corporate seal of the Village of Manchester and to attest the same.
- <u>Section 7</u>. The faith and credit of the Village of Manchester, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such bonds and bond anticipation notes as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such obligations becoming due

and payable in such year. There shall annually be levied on all water rents of said Village, a sufficient rate to pay the principal of and interest on such obligations as the same become due and payable.

Section 8. This resolution, or a summary hereof, shall be published in full by the Village Clerk/Treasurer of the Village of Manchester together with a notice in substantially the form prescribed by Section 81.00 of said Local Finance Law, and such publication shall be in each official newspaper of the Village, in the manner prescribed by law. The validity of said bonds and bond anticipation notes issued in anticipation of borrowing said funds may be contested only if such obligations are authorized for an object or purpose for which said Village is not authorized to expend money, or the provisions of law which should be complied with, at the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication; or if said obligations are authorized in violation of the provisions of the Constitution.

<u>Section 9</u>. This resolution shall take effect immediately upon its adoption.
