Mayor Buttaccio called to order the regular meeting at 6:00 pm.

The minutes of the Regular meeting on January 8, 2024 were read. A motion was made by Trustee Henry, seconded by Trustee Fine, to approve the January meeting minutes, unanimously carried.

A motion was made by Trustee Fine, seconded by Trustee Henry, to approve the January Treasurer's report, subject to audit. Unanimously carried. Bills were authorized for payment on Abstract #9 of Audited Vouchers, General Fund totaling \$47,098.03; Water Fund totaling \$1,182.78; Sewer Fund totaling \$49,832.59; ARPA totaling \$5975.00; and Trust & Agency Fund \$11,821.26; Capital Bond totaling \$0.00. Transfers approved.

Discussed – SPRING CLEAN-UP

On the agenda is to have a Spring Clean Up discussion with everyone attending. The Board set a February 12th date so to invite people to come. The discussion will be for any pros and cons of having Spring Clean-Up.

Trustee Henry addressed those present to start the discussion on clean up. No date has been set, K&D Disposal gives us the date. Trustee Henry went over past Newsletters reading what is allowed and what is not allowed to put to the curb. He handed out photos of abuses of this service and what it looks like. We do not want construction material (wood), no hot tubs, no outside users (non-village residents, family, friends, etc).

The village will leave those items that are restricted. Code Enforcement will tag unacceptable, give the weekend to remove. If not removed, a letter will be sent and 5 days will be given to remove the items. If not removed, a fine will be established, and a maintenance charge will be enforced.

Approved – RED JACKET JUNIOR BASEBALL (RJJB)

Approved - <u>BUILDING DEPARTMENT REPORT - 2023</u>

Code Enforcement Officer Steven DeHond submitted his 2023 Building Department Report for the Village of Manchester. He also submitted a breakdown of each permit issued and the number of fire inspections completed for the year. 61 permits issued with a construction cost total of \$2,121,268.00 and Permit fees collected totaled \$3,449.05. His full report is on file in the clerk's office.

LETTERS/EMAILS:

RGE is expanding their substation at 168 State Street and gave information on E-Vehicles.

Town of Manchester was denied by the DOT a speed reduction on Dewey Road coming into the village. **Steven Huber** sent an email concerning why are not all dead ends being addressed for turn arounds. Trustee Henry "because we have permission from them". Also a letter was sent last year to Mr. Huber addressing this at a previous meeting.

Sandy Cooke would like the infrastructure and fire hydrants on Pratt Road to be addressed. The DPW Supervisor stated it will be done in the spring.

Martha Doody is requesting the village allow camping on the trail for the Solar Eclipse on April 8th. The Village of Shortsville is allowing camping at Budd and Blunt Parks. According to our Code Book there is no camping on the trail. Permission was denied.

PUBLIC COMMENT:

Deb Halderman wondered when corrections will be made on the Veteran's Memorial as her family needs some changes. This will be looked into.

DPW REPORT

- Looking into using chlorine pellets instead of liquid chlorine for the village water system. Per Department of Health inspection. There is cost to changing the system.
- 26 dead Ash trees have removed from the trail. 21 to go. The Board approved a \$600 purchase for a limb saw.
- Working on clearing the end of Newton Street
- New Banners a motion was made by Trustee Fine, seconded by Mayor Buttaccio to purchase new banners and brackets at a cost of \$3300. Motion passed.

FIRE DEPARTMENT REPORT

- 23 Calls for January 2024. Total calls for 2023 was 251. Report will be sent to the Town's of Farmington and Manchester.
- 1781 is getting fixed
- Motion was made by Mayor Buttaccio, seconded by Trustee fine to approve purchase of rear light for 1731 (\$301.81). Motion was approved. It will be an LED light.
- 1946 LaFrance, is going to BOCES in Flint to have students (under supervision) work on it.
- Lexipol is a Public Safety Management service that the Fire Department is looking into to assist them in keeping up with regulations. The Board met with the fire department and agreed to purchase this program for \$11,000.
